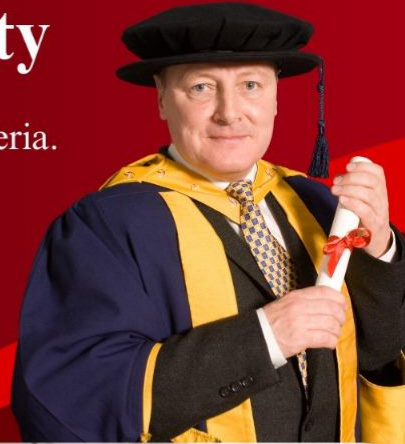

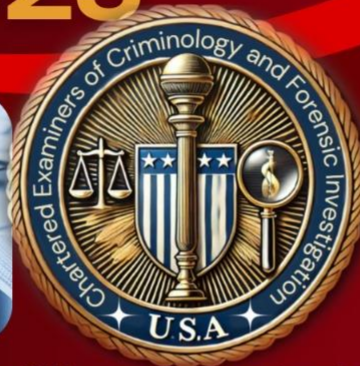

 - **Duration: Track 2** – 12 Semesters (Students who have completed 24 Credits in the NDU Advanced Diploma within two semesters with 12 credits each semester. The successful students will complete 120 Credits for the Ph.D. Programme, including the transfer credits from the participants' Master's programme. Candidates are to complete the programme within 42 months.

- **Track 1:** 30-35 % Course Work is required - 9-12 Months -Three/four Semesters(36-42 Credits)
- **Track 2:** 40- 45% Course Work Completion is required. 12-15 Months 4 \ Five Semesters (48-54 Credits)
